

The Key to Your Future Career May Be in the Bag

Houston Grocery Manufacturers' Representatives Association Scholarship Application

The HGMRA is a non-profit organization whose mission is to build and enhance the relationship among food industry suppliers, brokers and manufacturers and the retailers in the Houston area.

HGMRA's service project is their scholarship program, which has awarded over \$1.5 million to over 1000 students. The entire scholarship process—from application through funding—is a partnership between the HGMRA and Houston-area grocery stores.

This program enters its 40th year looking forward to a bright future in our industry, and if you are interested in making a career in the food industry—then read the eligibility requirements listed below. If you qualify, complete the application and turn it in to your store director.

Please read the information regarding the scholarship process CAREFULLY. You will need to attend an interview during a normal weekday. This means you will probably miss school or work and you will need to make arrangements for transportation to and from the interview site. Your interview appointment and other important information will be sent to you after your application has been processed and you are selected to participate in the interview round.

YOU QUALIFY FOR A SCHOLARSHIP IF YOU ARE—

A high school senior graduating this semester, planning to attend a college/university or junior college in Texas or Louisiana and completing a four year degree, planning to be a full-time student (taking at least 12 hours of coursework per semester with no more than 6 hours of coursework via internet or correspondence), your transcript reflects a C average or higher, interested in a career in the food industry, and a person who needs financial support in order to attain their college education.

YOU QUALIFY FOR A SCHOLARSHIP IF YOU ARE—

A high school graduate attending a college/university or junior college in Texas or Louisiana and completing a four year degree, **working full-time** and attending school part-time (taking at least 6 hours of coursework per semester with no more than 3 hours of coursework via internet or correspondence), your transcript reflects a C average or higher, interested in a career in the food industry, 24 years of age or younger, graduating May 2012, or after, and a person who needs financial support in order to complete their college education.

The Scholarship is a one-year award for \$1500 (\$750 per semester).

HGMRA funds the fall semester; your retailer funds the spring semester.

HOW TO APPLY—

High school seniors: Complete this application and **include a copy of your high school transcript**. Return the application to your store director by Friday, **January 13, 2012**.

High school graduates: Complete this application and include a **copy of your college transcript**. Return the applications to your store director by Friday, **January 13, 2012**.

ALL Applicants: Apply for this scholarship if you qualify. Do not forget to include your transcript and to follow directions. Complete the application neatly and thoroughly. Answer all questions that apply. **Essays are to be hand-written and limited to 250-word responses.**

THE PROCESS—

There will only be one round of interviews as application processing and scoring is the first round for qualifying for the scholarship. Applicants will not receive an interview if their application is incomplete (e.g. no transcript is included, store director's remarks are missing, essay questions are not complete, the application is incomplete or directions have not been followed) or if they do not meet the qualifications for the scholarship.

Interview teams consist of a HGMRA member and a representative from one of the area's grocery stores. Interviews will be held at the end of February. If you are selected for the interview round, a map to the interview site will be included with the letter containing your interview appointment. You will be expected to confirm your attendance at the interview.

Scholarship winners will be announced the week of March 5, 2012. Scholarship recipients are **required** to attend the HGMRA Trade Event held in April (date to be announced) where HGMRA members and grocery store representatives will honor them.

INSTRUCTIONS—

Read the application carefully. Follow all directions. Complete the application neatly. Request a transcript. Make sure your essays are **hand-written** and **within the 250-word limit**. Review the checklist at the end of the application. Sign the application. Submit your application before the January 13, 2012 deadline to your store director.
